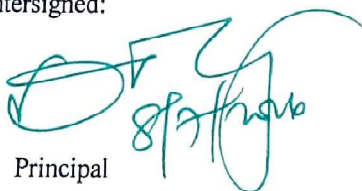

NOTIFICATION

It is to notify for general information of all concerned that as per the decision of the competent authority of the Vidyasagar University the following amendments in the Regulations of CCFUP (NEP) for Undergraduate Studies, 2023-24 shall be in force with immediate effect.

- i. Clause 16.1(g) is to be reread as “All the supplementary papers to be cleared upto 5th Semester for 3-Yr. Multidisciplinary programmes, otherwise students shall not be allowed to appear in the 6th Semester examination”.
- ii. Clause 16.1(m) is to be reread as “Students of 4-Yr. Honours programmes must clear all the supplementary papers before being promoted to the 8th Semester, otherwise student shall not be allowed to appear in the 8th Semester examination”.

In view of the above amendments, undergraduate students of 4-Yr. Honours programme with supplementary paper in the previous Semester(s) be allowed to appear in the ensuing 6th Semester Examination, 2026 (under CCFUP-NEP) subject to having valid chance.
