

Format for Presentation of Best Practices (Solar PV Plant)

1. Title of the Practice: Solar Power Plant

2. Objectives of the Practice:

- To operate and maintain the PV system and keep the same in good repair.
- To collaborate with solar energy companies, utilities, and the government to attract research grants from state and federal government agencies.
- Being a college in a remote area and students generally belonging to tribal class, a solar power plant is an immediate help to the institution if the most of the energy requirement of the institution is provided by the solar PV plant.

3. The Context:

The project has been initiated with an application to the Chief Engineer, WBREDA, Bikalpa Shakti Bhaban, requesting for installation of Solar panels at the premises of the institution to meet the massive energy requirement of the college to smoothly run the institution.

4. The Practice:

The College asked the *West Bengal Renewable Energy Development Agency (WBREDA)* on 05.06.2018 to survey the college premises and to prepare a plan with estimates for the project.

WBREDA, in its reply, informed the institution that the agency may install rooftop solar PV power plants in Net-metering mode and there will be no storage arrangement. They also stated the requirements and general budget for installation of solar PV power plants for two ranges of capacity.

However, the College needed a detailed and customized proposal to arrange funds. The WBREDA was intimated for the same along with requisite documents as they asked over telephonic conversation.

WBREDA in its reply sent us a detailed budget as per available free rooftop area of our college and also on the basis of Government norms for any institution can maximum generate from solar source based on its consumption.

As a result of our sincere effort the project was included in a master project of the Pollution Control Board of Govt. of West Bengal for installing Solar PV power plants in Government institutions. Sunshine Power Products Pvt. Ltd. Was given order from Pollution Control Board to install a solar PV power plant of capacity 5kWp with maintenance for five years.

5. Evidence of Success:

Solar PV power plant of capacity 5kWp has been successfully installed in Jhargram Raj College and it is generating solar power satisfactorily. Net-metering arrangement is due, however, expected to be installed by WBSEDCL shortly which will quantify the generation as well as reduce the electricity bill of the college. .

6. Problems Encountered and Resources Required:

The budget that WBREDA submitted was Rs. 2,29,500,000/- , which in view of the college was difficult to arrange from the Government. Therefore the project was scaled down and a proposal for a Solar PV Plant of capacity 12kWp was submitted to Higher Education Department, Govt. of West Bengal requesting for sanctioning a fund of Rs. 7,95,600/- for the same.

The college had been following up to arrange the fund from the Govt. of west Bengal. However, as a result of our sincere effort the project was included in a master project of the

Pollution Control Board of Govt. of West Bengal for installing Solar PV power plants in Government institutions. Sunshine Power Products Pvt. Ltd. Was given order from Pollution Control Board to install a solar PV power plant of capacity 5kWp with maintenance for five years.



1. **Title of the practice:** Cine Club

2. **The context that required the initiation of the practice (100 – 120 words):**

Screening of quality movies with the potential of promoting learning and perception of socio-cultural issues, historical contexts, political thoughts and mythological beliefs across the world and in all eras has been continuing since the last few years as an extended part of the teaching-learning process. Students can understand a text, a concept more easily if the mode of teaching is in audio-visual method. The screening of movies has received wide and enthusiastic participation from students of our college. Hence, Cine club has been formally set up at Jhargram Raj College.

3. **Objectives of the practice (50 – 60 words):**

Imparting communicative English skills is one of the aims of the Club. Given the socio-economic profile of the students of the College, their exposure to English language is dismally limited. Cinema is a scientifically proven medium to develop language learning abilities. It can impart value based education also. History and Cultural Heritage of our country as well as across the globe can be better understood via historical movies and documentaries. Movies are helpful tools to convey various issues of the society such as gender equality, caste issues, need of education and many more. More civic sense and duty towards society can be better realized with the help of this cine club.

4. **The Practice (250 – 300 words):**

The cine club was formed on 17th of December, 2019 comprising teaching, non-teaching staff and student representatives. All the participants were provided with the specific form to join the club.

club members were compelled not to take any more initiatives to engage in activities and screening of the movies due to the pandemic situation and the lockdown.

5. **Obstacles faced if any and strategies adopted to overcome them (150 – 200 words):**

The audio-visual system of the seminar hall was not upto the mark and due this reason the sound clarity of the movies or the documentaries was not good enough. A projector of 4k compatibility along with an excellent sound system (JBL Sound System) and setup for recording (with open source recording app) has already been installed.

6. **Impact of the practice (100 – 120 words):**

Learning can essentially be improved if it can be channelized via audio-visual perception instead of mere classroom teaching. Without any doubt cine-club has motivated the students to engage in learning and regularly attend the classes. In graduate courses students are sometimes bound to learn specific subjects and can't access the entire encyclopedia of knowledge. Cine club helps students to realize the broader perspective of learning.

7. **Resources required:**

Seminar hall of the college was used for the screening of the movies. All teaching, non-teaching staff and students were allowed to join the cine-club without any registration fee.
