MEMORANDUM OF UNDERSTANDING

BETWEEN

Jhargram Raj College, a reputed academic higher education institution, established in **1949**, located at Jhargram, West Bengal, India, PIN 721507, as the FIRST PARTY;

AND

Mahishadal Raj College a reputed academic higher education institution, established in 1946, located at Gar Kamalpur, Mahishadal, Purba Medinipur, West Bengal, India, PIN-721628 as the SECOND PARTY;

Both the parties herein have noted the importance the value of cooperation and have agreed to enter into this Memorandum of Understanding (MoU) regarding academic collaboration. The purpose of this non-binding MoU is to make possible academic and cultural exchange between both the parties based on the principles of mutual equality and the reciprocity of benefits. NOW THIS MEMORANDUM OF UNDERSTANDING is agreed by and between both the colleges hereto as follows:

1. Objectives, Scope, and Major Activities

Both institutions agree to encourage the development of the following types of activities:

- Visits and formal exchanges of faculty, scholars and administrators in specific areas of education, research and outreach.
- Cooperate in Under Graduate & Post Graduate education and training through library as well as laboratory resources.
- Organize joint conferences, webinar, symposia, or other scientific meetings on subjects of mutual interest.
- · Exchange of academic information and materials.
- Pursue avenues for under graduate and post graduate student exchange during the academic year.
- Explore the possibilities for developing joint research programs and collaborations.

2. Responsibilities of the Institutions

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources, space and other resources. Accordingly, the functioning of any exchange and cooperative programs based on this MoU shall be conferred and determined between the two institutions. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

3. Duration and Option to Amend, Extend or Terminate

This MoU will become effective when signed by authorities of both institutions. The agreement will remain in effect for five years from the date of signature given below, and may be renewed or amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.

4. General Terms

This MoU is not intended to, and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable by law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents. 

Mushroom polysaccharides, especially glucans have become a prime theme of research for immunobiologists due to their immunomodulatory and antitumor properties [2-7]. A branched α -Dglucan having α -(1 \rightarrow 4)-D-glucopyranosyl main backbone chain with $(1 \rightarrow 6)$ - α -p-glucopyranosyl side chain has been identified from the fruiting bodies of Coprinus comatus [17]. Moreover, linear glucans containing both α - and β -glycosidic linkages such as α -(1 \rightarrow 4),

 β -(1 \rightarrow 6)-D-glucan from Astraeus hygrometricus [18] and α -(1 \rightarrow 4), β -(1 \rightarrow 3)-D-glucan from Termitomyces microcarpus [19] have also been reported.

Polyporus grammocephalus is an edible mushroom commonly found in the hill areas of West Bengal, India. It generally occurs on dead hard wood causing white rot and occasionally growing as a parasite on living trees. Polyporus grammocephalus contains 20.6% of protein, 41.11% of carbohydrate, 24.62% of crude fibre, 8.75% of free amino acids, 2.03% of fat and sufficient amount of important minerals such as calcium, potassium and phosphorous, etc. [20]. As claimed by a published report, P. grammocephalus contains essential oils, phenols, terpenes, steroids, fatty acids, sugars, anthraquinones, coumarins, anthrones, tannins, flavonoids, and alkaloids [21]. So, it can be considered as an excellent and safe dietary component. P. grammocephalus is also known to show significant antioxidant, antimicrobial and NOS activation properties [22,23]. Different solvent extracts of P. grammocephalus showed cytotoxic and chemo protective effects [21,24]. Bioactive components isolated from certain polyporus species like P. confluence, P. umbellatus, P. sulphureus, P. badius, and P. sclerotium have been reported to exhibit antitumor, immune-enhancing, antibacterial, anti-inflammatory, antiviral, anti-aldosteronic & diuretic effects [25-29]. The present article deals with an immunoenhancing $(1 \rightarrow 3)$ -, $(1 \rightarrow 4)$ - α -glucan which was isolated from the alkaline extract of the fruit bodies of Polyporus

Removal of dyes using polymers of intrinsic microporosity (PIMs): a recent approach

Removal of dyes from various industrial effluents is a great challenge, and cost-effective methods and materials with high dye removal efficacy are in high demand. Adsorption, nanofiltration and photocatalytic degradation are three major techniques that have been investigated for dye removal. PIMs are promising materials for use in these three methods based on their attributes, such as microporosity, solution processibility, high chemical stability and tunability through facile synthesis and easy postmodification. Although the number of reports on dye removal employing PIMs are limited, some of the materials have been shown to exhibit good dye separation properties, which are comparable to those of the state-of-the-art material activated carbon. In this highlight, we make an account of progress in PIMs and PIM-based composite materials in different dye removal processes over the last decade. Furthermore, we discuss the existing challenges of PIM-based materials and aim to analyze the key parameters for improving their dye removal properties.

1. Introduction

The increasing level of toxic chemical wastes, such as hazardous metal ions, drug residues, dyes, agrochemicals and greenhouse gases, is contaminating air, water and soil. Due to globalization, emission of these pollutant materials from different industries is also increasing. Among these pollutants, dyes are considered as major organic contaminants. 1,2 Dyes are colored compounds that are used to impart color to different substrates, such as paper, fabric, leather products, plastics, ink,

cosmetics, food products, *etc.*, which require more than hundred thousand of different dyes. 2,3 In fact, more than a million tons of dyes are produced every year for different industrial purposes, and 10–15% of them are released with the industrial wastes into water bodies.

Dye molecules are composed of two components, chromophores and auxochromes. 4,5 Chromophores are unsaturated functional groups which are responsible for the color of dyes and auxochromes are functional groups (e.g., -COOH, -OH, -OR, -NH₂), covalently connected to chromophores which can further tune the color and often help to increase the solubility of dyes. Dyes are classified as neutral, cationic and anionic dyes based on the charge present on the chromophores. Based on the origin, they can be natural or synthetic. Natural dyes are
