Sealed tender are invited from the local interested persons who are willing to open a cheap canteen inside the college premises for the students & staff of Jhargram Raj College especially for meal, tea & Tiffin.

The tender shall be received by 1.30 p.m. on 20.09.2023 and shall be opened on the same day at 3.00 p.m. in the presence of the interested tenderer.

Rates and specification should be quoted in the respective tender inclusive of all taxes and delivery charges, if any.

License related to food items must be submitted along with the tender.

The undersigned reserves every right to reject /cancel any or all tenders, alter/amend the terms & conditions of the tender and also to close the Canteen without assigning any reason thereof, if required.

Validity of the lowest tender along with terms & conditions shall remain valid for 1 (one) year with effect from the acceptance of the rate. However, validity of tender may be extended for further period on satisfactory performance by the successful bidder.

In case submission of any false and misleading information/misconduct and/or repeated unsatisfactory execution of contract, the undersigned reserves the right to impose penalty or to terminate the contract/work after giving 7 days notice.

If any abnormally high or low rate is received in comparison to the prevailing market rates, the tender will be rejected.

Terms & Conditions :

1. Canteen will run on all working days and shall remain open during such hours as may be decided by the college authority.
2. The contractor selected for canteen service, will be required to maintain highest level of cleanliness and standard of hygiene.
3. The personnel appointed by the tenderer must have proper and clean uniform for their identification. The personnel so appointed should have the basic knowledge of personal hygiene and safe & clean methods of food handling. All the persons who are working there has to be vaccinated against COVID-19 and good health.
4. The quality of the raw materials to be used for preparation of food in the college canteen should be of highest standard and fresh.

5. The fuel to be used for cooking will only be LPG and shall be arranged by the contractor. The contractor should have valid commercial connection in its name.
6. The contractor will be responsible for maintaining adequate number of persons engaged in cooking and serving of food as well as disposal of garbage and leftover food in proper place in a dustbin.
7. The contractor should keep the staff canteen complex clean. If, at any point of time, the canteen and its premises are found to be unclean, the contractor shall be held responsible and action deemed fit shall be taken by the competent authority.
8. The contractor shall bear all the expenses for running the canteen and the college authority shall not in any manner be able for any damage cost on accidents like theft, burn, fire, electric shock or bear any compensation for damage or injury cost to its workmen during discharging their duty.
9. The contractor must possess the requisite valid license issued by the competent authority for carrying out the business and shall be responsible for complying all laws pertaining with the services in question as well those pertaining to employment of persons under him.

The decision of tender selection committee in this respect will be final.


